Policy in respect of balances carried forward

The policy of the Parish Council for the year ended 31 March 2009 (agreed at the Council meeting on 5 September 2007 and restated at the meeting on 7 November 2007) was to reduce balances by initiating a programme of works to improve the village environment.

The precept applied for in 2018 was kept at £7,500 due to the planed improvement to the village signage and any work required when the undergrounding project goes ahead. Reserves agreed this year.

- New street lights required as part of undergrounding: £4,500 (ongoing from previous year)
- 2. Play park (remaining grant money kept for maintenance); £644.08 (£108.33 spent on maintenance 2016/2017)
- 3. Lions Christmas Float (money reserved for children's event): £161.67 is remaining balance. The Parish Council will be exploring suitable children's activity to suit all ages.
- 4. The Council received a donation from the Mary Parnham Chairity which is to be ring fenced and used to benefit children under the age of 25 primarily from Lyddington

Additional expenditure, as it occurs, is met from retained balances.
